

Bazan Ltd. Privacy Policy

Important: By using Bazan's Services (as defined below in this document and in the Terms of Use, which should be read together with this Privacy Policy), you affirm your consent that any personal information that you provide may be used by Bazan in a manner and for the purposes described in this Privacy Policy below.

You are not legally required to provide your personal information, and you hereby acknowledge that any personal information has been provided by you voluntarily. By using the Services, you signify and affirm your informed consent to these Terms of Use, and to the collection, processing and sharing of your personal information for the purposes noted below. If you do not agree to these Terms of Use, please refrain from using Bazan's online services.

We, at Bazan Ltd. ("**Bazan Group**" or the "**Company**"), recognize the importance of maintaining privacy. This Privacy Policy applies for all the software, services, information, tools, features and functions that are offered on the websites of the Company or its subsidiaries or affiliates (collectively: the "**Services**") and describes how Bazan collects and uses personal and other information, including information relating to the use of the Services. Any terminology that is not defined in this Policy will have the meaning given to them in Bazan's Terms of Use.

The Information that we Collect:

In order to provide our Services, we receive, obtain and/or may collect the following types of information:

- **Information that you provide** - When you visit the website and register for Bazan's Services (including active registration) we may require you to provide contact information, which will include, among other things: your full name, email address, company name.

Personal Information means any information that can be used, whether individually or combined with other information, to identify an individual, including and without derogating from the foregoing generality, first and last name, personal profile, email address, residential address or other physical address or other contact details.

- **Contact Us Inquiries** - If you send us an inquiry via the Contact Us form on our website, you may be required to provide certain information such as your name,

email address, telephone number, job title, company and the subject of the message, to enable us to respond to your inquiry.

- **Request for Tour** - If you send us a request for a tour using the Contact Us form on our website, you may be required to provide certain information such as your name, email address, telephone number, name of your organization and number of tour participants, to enable us to respond to your inquiry.

Use of Google Analytics:

Bazan uses the information it collects to understand user activity and preferences in order to improve the way the website works and looks, and to create new features and functionality. We currently use Google Analytics to collect information about how the website is used, such as how often you visit the website, which pages you viewed, which other websites you visited before using our website. No personal information is collected through our use of Google Analytics, and the Company does not combine and/or consolidate the information collected by using Google Analytics with individually identifiable information of the users of our website. The way Google uses and shares information collected by Google Analytics concerning users of our website is subject to the terms of use of Google Analytics, which is available at <http://www.google.com/analytics/terms/us.html> and Google's Privacy Policy, which is available at <http://www.google.com/policies/privacy/>.

Cookies:

In addition to the information that we collect as described above, we may also make use of technology to collect non-personal information about use of the website. For example, Bazan's web server may automatically record which pages visitors to our website have viewed and which web browsers visitors have used. Such technology does not identify you personally, it simply allows Bazan to gather statistics about visitors to our website and of how they use our Services. The website also contains links to other pages on the Bazan website. Bazan may use technology to track how frequently links are used and which pages on our website visitors choose to view. And again, this technology does not identify you personally, it simply allows Bazan to gather statistics on the use of these links. This information might be collected by using cookies or similar techniques. Cookies are text files created by your browser according to a command from corporate computers. Some cookies expire once you close your browser and others are stored on your computer's hard drive. For example, if you use Windows operating system and a Microsoft Internet Explorer browser, you may find cookies stored in C: Windows.Cookies and C:Windows.Temporary Internet Files. The information in the cookies is encrypted and the Company takes precautions to ensure that only its computers can interpret and understand the information stored in them.

We only use cookies relating to you when you provide us with your consent by clicking the appropriate button when you visit our website. You may opt out of consenting to cookies at any time by re-visiting our website and selecting the appropriate options in your web browser. You can also set your browser to not accept cookies from this website. Please note that if you do not consent to the use of cookies, you might not be able to use all the functions and features on our website.

How we use Personal Information:

We may use the personal information you provide and/or the information collected by us for the following purposes:

- To provide, operate and improve our Services.
- To notify you of new services.
- To respond to your queries or to provide you with additional information at your request.
- To send you notices regarding your use of the Services, including notices regarding violations of use.
- To occasionally send you, via the communications media available to us, such as e-mail and/or SMS, marketing and advertising information regarding the Company and its activities.

Sensitive and Third Party Information:

You may not write, pass on or post any information via the Services relating to third parties without their express consent. You may not write, pass on or post any sensitive information via the Services, whether such information relates to you or anyone else.

Information Sharing:

Bazan does not sell and/or disclose and/or divulge your personal information to any third party or other organization, other than in the following cases:

- To service providers, including those outside of Israel, who have been hired to perform services on behalf of the Company or its affiliates, including in connection with the website and/or the Company's Services;
- To our subsidiaries or affiliates that act on our behalf and/or if the disclosure of such information is required for the purpose of conducting the Company's business.

- If you violate these Terms of Use or this Privacy Policy, or if you perform actions via the website or with regard thereto, that are deemed to be unlawful, or attempt to perform such actions;
- In the event of any dispute, argument, claim, demand or legal proceedings, if any, between you and the Company;
- If the Company believes that disclosure is necessary in order to prevent bodily harm or damage to property (to you or to a third party) or with regard to an investigation into suspected unlawful acts;
- If the Company is required by law to provide the information to a third party, including in the event that the Company receives a judicial order instructing it to disclose your information or information about you to a third party or in response to a request from an enforcement agency or other government or public authority .
- If the Company organizes its activities through another corporation, and in the event that the Company merges with another entity or merges its activities with the activities of a third party, in whole or in part, it will be entitled to pass on information concerning you to such corporation.

Privacy of Children:

If you are a minor under the age of 18 you must obtain parental consent before using our Services. Bazan will not intentionally contact or communicate with children under this age without such parental consent. If you have reason to believe that a child has provided us with personal information, please contact us at the above address and we will endeavor to delete this information from our database.

Links to Third Party Websites:

You hereby confirm that you are aware that, when providing your personal information and registering, the websites that you access via or by using the Company's website or the links available on that website, are not subject to the Company's Privacy Policy, but to the privacy policies of those linked websites and the provisions of law.

Use of Non-personal Information:

We may use or divulge non-personal information (as defined below) to third parties at our discretion, including among other things, to improve our Services. **Non-personal Information** means information that does not contain individual and

identifiable user information, such as aggregated information about the use of the Services.

Information Protection:

- We take appropriate security measures to protect against unauthorized access, alteration, disclosure or destruction of information. However, no method or online data transmission or electronic storage can be guaranteed to be 100% secure.
- We strive to protect the reliability, accuracy, integrity and relevance of the personal information that we collect and secure the privacy and safety of our customers. We store your personal information for only as long as is reasonably required for the purposes for which it is collected or to comply with any valid statutory or ethical reporting or document retention requirements.

Access to and Updating of Personal Information:

- Once you provide us with personal information, we want to maintain the accuracy of such personal information. Consent for Information Processing:

With regard to any personally identifiable information that you actively provided under this Privacy Policy, all users fully understand and unequivocally agree to this Privacy Policy and consent to the collection and processing of such information. Such consent may be rescinded and will take effect upon receipt of your request to rescind. The server on which our website is hosted and/or through which the Services are processed may be located outside of the country from which you have access to the website and may be outside of the country in which you reside, and therefore other regulations or privacy laws may apply. Some of the uses and disclosures mentioned in this Privacy Policy may include passing on your personally identifiable information to several countries around the world that may have different levels of privacy protection than that in your own country. By typing in your identifiable personal information on our website, and as part of the Services, you hereby agree, acknowledge, and affirm your consent that we may collect, use, send and disclose your identifiable personal information, as described in this Privacy Policy. If you do not agree to the terms of this Privacy Policy, please do not use this website.
